### **Subscriber Terms & Conditions**

**Date: September 1<sup>st</sup> 2008**

I declare that the information provided in the "Breeze in Business Order Form" is true and correct. If my purchase application is accepted, I agree to abide by the Terms and Conditions as set out in these Subscriber Terms and Conditions.

The products and services you, the buyer, are purchasing are clearly explained and they range in scope as per Schedule A.

I understand that BIB is a service oriented company which provides access to the various services and products as listed in Schedule A.

I understand that I have placed an order for a BIB subscription.

Prior to entering into an agreement with BIB, my subscription will only become valid after payment of the above amount.

Please accept my agreement for subscription to BIB as signified by my signing the Breeze in Business order form. I have purchased a Breeze in Business 3 - Year subscription solely because I wish to have the services and products provided by BIB.

I understand that I may cancel this transaction at any time prior to midnight of the fourteenth (14<sup>th</sup>) business day from the date of signing the Breeze in Business order form. Please see the notice of cancellation at the bottom of this document for an explanation of this right.

The following provisions govern the ownership and use of all Breeze in Business subscriptions, hereon known as BIB.

#### **Definitions:**

The following terms when used herein shall have the following meanings; BIB is a service oriented company.

"Associated company" or "supplier" shall mean a third party with whom BIB has entered into a contract wherein the third party provides services to subscribers of BIB.

"Breeze in Business order form" means the order form on which the prospective subscriber signs, and thereby makes application to be accepted as a Subscriber of BIB.

“Subscription Fee” means the payment of:

£5,800 GBP (Five Thousand, Eight Hundred Pounds Sterling) for a **Director Business Center** (DBC) or £2,500 (Two Thousand, Five Hundred Pounds Sterling) for an **Executive Business Center** (EBC) or £1000 (One Thousand Pounds Sterling) for an **Associate Business Center** (ABC)

“Subscriber” means a person who has been accepted by BIB for the services rendered under the Breeze in Business package and who has paid the subscription fee. A person ceases to be a Subscriber if he or she terminates their subscription or cancels their purchase of a subscription.

1. The placing of an order to become a Subscriber of BIB can only be made following the attendance of the ordering party or their authorized representative at a presentation (either on the internet via the iConference, a personal one-on-one business meeting or group business meeting or presentation, or via telephone) in which the services of BIB have been explained and the Terms and Conditions of the subscription and subscription fee have been fully disclosed.
2. BIB is entitled to refuse an order for any subscription in its sole and absolute discretion.
3. A BIB Subscription becomes effective when the BIB order form is accepted and the applicant has paid the subscription fee.
4. Upon acceptance of the BIB order form and payment of the subscription fee a subscription username and password will be issued to the Subscriber and the Subscriber will be provided with such additional information and material as BIB deems necessary from time to time so that the Subscriber will be aware of all services of subscription.
5. The Subscriber must inform BIB in writing of any change in his/her registered business address.
6. BIB has contracted with various companies to provide services to Subscribers which services will change from time to time. BIB will at all times provide updated information as to services available.
7. The purchase by the Subscriber of specific products or services is subject to availability at any given time and is subject to the normal policies and procedures of the associated company.
8. All communication between the Subscriber and BIB must include the subscription username.
9. The term of subscription is for 3 years. Subscription is personal to the Subscriber and may not be sold. In the case of subscriber death, with the consent of BIB management, the subscription may be transferred to another trading entity, a next of kin or as otherwise described in the last will and testament of the deceased subscriber. Subscriber heirs become the owner of a subscription for the balance of the term.
10. One month prior to expiration, the subscriber will receive an email from BIB Administration to renew the subscription. If subscriber does not renew the subscription for another BIB package then the subscription will expire.
11. Subscriber inquiries shall be made through BIB for referral to the associated companies for provision of products and services. Payment for all subscriber products and services shall be arranged and handled exclusively between subscriber and the actual product or service supplier.
12. Subscriber agrees to look solely and exclusively to the product and/or service supplier as regards all matters concerning the product or service, including warranties and guarantees. Subscriber understands and agrees that BIB shall have no liability of any kind, including but not limited to products liability, warranty, or guaranty regarding products and/or services purchased from associated companies or suppliers of BIB.
13. The purchase by subscriber of specific products and/or services is subject to the policies of the provider of the products or services.

14. Subscriber services are available to subscriber for both business and personal use, and to his or her immediate family members. Note: BIB subscription, Travel benefits entitles the subscriber, partner/spouse and dependent children (aged up to 19 years) to BIB discounted travel and offers.

15. No person other than authorized representatives of BIB is authorized to make representations or furnish any information with respect to the services and terms of subscription, and if any such information or representation is obtained by the Subscriber from unauthorized persons, such information and representation must not be relied upon. This Agreement will be governed by and construed in accordance with the laws of the State of Nevada, and all disputes and claims relating to BIB, the Subscriber Agreement, the products and services of BIB, or any other claims or causes of action relating to the performance of BIB hereunder shall be settled totally and finally by arbitration in Las Vegas, Nevada, or such other location as BIB prescribes, in accordance with the Federal Arbitration Act and the Commercial Arbitration Rules of the American Arbitration Association. If a Subscriber wishes to bring an action against BIB for any act or omission relating to or arising from this Agreement, such action must be brought within one year from the date of the alleged conduct giving rise to the cause of action. Failure to bring such action within one year shall bar all claims against BIB for such act or omission. Subscriber waives all claims that any other statutes of limitations applies.

The decision of the arbitrator shall be final and binding on the parties and may, if need be, be reduced to a judgment in any court of competent jurisdiction. Each party to the arbitration shall be responsible for its own -- costs and expenses of arbitration, including legal and filing fees. This agreement to arbitrate shall survive any termination or expiration of the Agreement. The parties consent to jurisdiction and venue before any federal or state court in Clark County, State of Nevada for purposes of enforcing an award by an arbitrator or any other matter not subject to arbitration.
